PREVENTION PROGRAMMING:

Traffick011 conducted 125 youth prevention outreaches in 2019 across Texas, reaching high-risk youth in juvenile detention centers, youth shelters, and schools with prevention curriculum on how to stay safe. Traffick911 spoke to 7,544 general audience adults across Texas in trafficking awareness and prevention.

IDENTIFICATION PROGRAMMING:

In 2019, Traffick911 strategically trained over 500 first responders and professionals such as school staff, and other victim-serving organizations in order to promote the identification of victims across Texas.

4c (Code:) (Expenses \$ **681,630** including grants of \$) (Revenue \$)

EMPOWERMENT PROGRAMMING:

In 2019, Traffick911 directly served 212 victims of child sex trafficking with advocacy and crisis response services. Traffick911's field-based team responds to law enforcement when a victim is recovered and dispatches to their location within 60 minutes. Highly-trained advocates work to establish felt safety, meet material needs, implement safety plans, and ensure safe housing is secured. Advocates and mentors work with survivors into adulthood for long-term healing and protection from re-victimization through trauma-informed case management, goal-planning, and connection to safe community relationships.
